5. Do you agree that livestock and horse export journeys for slaughter and fattening are unnecessary? Please explain your views.

Yes. The UK, which prides itself on having some of the highest animal welfare regulations in the world, has a responsibility to ensure that those high standards are maintained for the whole of an animal's life. Our country cannot claim credit for minimising animal suffering if they are going to send their animals on gruelling journeys, during which they suffer exhaustion, injury, hunger, dehydration and heat stress, to countries with much lower, or non-existent, animal welfare rules. A modern, civilised country should show its farmed animals enough respect that they keep their journey to slaughter as quick and painless as possible.

In the twenty first century - a time when technology allows meat to be easily preserved for export - there is no need, absolutely no justification, for the brutality that is live export.

6. Do you agree that in order to prohibit livestock and horse export journeys for fattening where the animal will be slaughtered soon after arrival, these export journeys where animals are slaughtered within 6 months of arrival should be prohibited? Please explain your views.

My answer is the same as that to question 5. All live exports should be banned.

Where there's a will there's a way. It's no longer the dark ages. Do the right thing.

I see no reason why animals cannot be slaughtered at the slaughterhouse nearest to the farm in order to keep travel to an absolute minimum. The RSPCA states that journey times should not exceed those permitted under the RSPCA's species specific higher welfare standards and has shown the maximum journey times permitted under these standards to be commercially viable.

No. In humans there is no nutritional need for animal products of any kind, so eating them is done only for pleasure. Producing and selling them is done only for profit. Pleasure and profit provide no justification for increased and prolonged suffering of any kind. No exceptions. End live exports.
